SO MANY WAYS

In 1840 a group of lawyers and judges, led by the Honorable George William Brown, came together to discuss the need of the local legal community for a law library. Efforts to have the City establish one had been unsuccessful, so, the question was, where to go from there. In the best traditions of America the answer they arrived at was to establish their own. Thus was born The Library Company Of The Baltimore Bar.

Over the course of the ensuing 176 years, the Bench and Bar have advanced the causes of the Library in a myriad of ways beyond those that would automatically come to mind. These men and women have helped the Library to become one the finest law libraries in the country, boasting collections that are both "wide and deep," computer research databases that are all encompassing, and services that are designed to meet the needs of practitioners from the largest of firms to the smallest.

Of course, the most significant and widespread form of support that the Library receives is through memberships. For the overwhelming part it is the membership that allows us to provide what we do. The book, the computer database, the M.V.A. search, the lecture, the educational seminar, none would be possible without your membership. In this election year I hope all of you remember that just as every vote counts, so too does every membership.

By now, some of you are probably asking "What about that other stuff you were talking about?" I am glad you asked.

Books – I have had so many instances where someone has said to me "I have a copy of such and such, and although I doubt that you're interested..." Well, quite frequently it is something that we are interested in and it fills a gap in our present or historical collections. One of the Library's favorite speakers, Professor Jim O'Hara, a man with an unmatched knowledge and passion for Supreme Court history, recently donated a substantial number of books to the Library on the history of the Court and of various Justices.

Continuing Legal Education Series – At one point in time I had a conversation with Paul Mark Sandler about the possibility of his presenting a program at the Library on some aspect of the law of evidence. Well, I soon found out that when you bring up the possibility of a program with

Paul, you just stand back and watch. It is a thing of beauty. So, our little talk eventually manifested itself into "Trials and Evidence: What You Need to Know to Succeed in Court," an epic ten part, monthly series that includes not just Paul Mark Sandler as a speaker but also the Honorable Paul William Grimm; the Honorable Benson Everett Legg; and Rignal W. Baldwin, Esquire. I am currently experiencing the same whirlwind effect with Jim Astrachan. A veteran of one Library presentation, which also featured the Honorable Julie Rubin; Donna Thomas, Esquire; and H. Jay Spiegel, Esquire, Jim is currently developing a number of series for the Library including "Lunch With A Judge," which will be "kicking off" in the fall.

Bar Library Lecture Series – On May 9, 2007, the late Honorable William Donald Schaefer, former governor of the State of Maryland presented "Reflections on His Early Years in the Practice of Law." Since that memorable night the Library has sponsored talks by members of the Bench and Bar, noted authors and academicians. They have shared their knowledge providing us with evenings that were that most excellent of combinations "entertaining and informative," in the overwhelming majority of cases without recompense of any kind. When you contemplate how much time and effort these individuals spent on the preparation of their presentations, it truly brings the generous nature of what they bestowed upon the Library into focus.

Sketches – Photos – Music – The arts do indeed live at the Library. Those extraordinary sketches that you see around the Courthouse (more about those later in this newsletter), were a gift to the Library from George W. Della, III. Recently, the Library received a gift from Mr. Charles W. Mackey, Jr., retiring as a clerk of the Circuit Court for Baltimore City after fifty-one years (good luck Mr. Mackey), of some extraordinary photographs of the swearing in of various individuals to what was the Supreme Bench of Baltimore City. These photographs that include the Honorable Harry A. Cole and the Honorable Joseph H. H. Kaplan, capture moments of historical significance and personal triumph for some of the most significant figures in the jurisprudential history of Baltimore City. So for the eyes, so for the ears. For Joe Williams and his guitar; for Jonathan Rudie and his mandolin; for Jack Gohn and Paul Sandler, two "wicked" harmonica players, thanks for the sweet sounds.

Bequests – In thanks for what the Bar Library provides to the legal community, for what it had provided them, the Library has been the beneficiary of numerous bequests over the years, including those from our former Head Librarian Ms. Kai-Yun Chiu to one of our most recent, and largest, to date, that of Franklin I. Freeman, Esquire.

The Library in every significant way is what it was in 1840, only more so. It is still that noble endeavor set into motion to provide services and collections to the Bench and Bar. It was, is and always will be The Library Company OF THE Baltimore Bar. I ask for your continued support of our Library and that you ask yourself, "what can I do, how can I help, to make our Library even better than it is, not just for myself, but for others and for those yet to come."

Courtroom Sketches

In June 1998, an exhibit of courtroom drawings was held in Baltimore's City Hall entitled "Otter in the Court." Well, owing to the generosity of Ms. Otter's son, George W. Della, III, the Library came into possession of the sketches of the late Ms. Otter a number of months ago. On May 26, a celebration of Ms. Otter's work "Otter in the Court – Part II," was held in the Main Reading Room of the Library. Although a number of sketches were purchased that night by individuals anxious to acquire their piece of Baltimore legal history, many still remain. These signed originals truly are amazing and would greatly enhance the décor of any law office. The sketches, feature past and present members of the Bench and Bar, including individuals such as the Honorable Elsbeth Levy Bothe; M. Albert Figinski, Esquire; the Honorable Mabel Houze Hubbard; and the Honorable Joseph H. H. Kaplan, to name just a few.

There are three ways that you can view the sketches. The first and easiest is to visit the Library's Web Page at <u>www.barlib.org</u> and click on "Courtroom Sketches" which is on the left hand side of the Page. There you will find hundreds of numbered sketches that we invite you to browse. If one of the thumbnail images looks familiar to you, just click on it to enlarge it. If you spot yourself, a relative, friend or perhaps that first judge you appeared in front of, could you please let us know who is pictured. We hope to eventually caption all the sketches, both those that are hanging in the Courthouse as well as the ones that are in our online display.

Did I say those hanging in the Courthouse? Hadn't you heard? Currently hanging along the walls of the 1^{st} , 2^{nd} , 4^{th} and 6^{th} floors of the Mitchell Courthouse, as well as a number of stairwells and the vacated phone booths on the 2^{nd} , 4^{th} , 5^{th} and 6^{th} floors, is a veritable gallery featuring sketches by Ms. Otter.

Lastly, the Library has twenty framed sketches featuring jurists from the legendary Stephen Montanarelli, Esquire to current Court of Appeals member the Honorable Clayton Greene, Jr., rendered during his days on the District Court of Maryland. The next time you are in the Courthouse, or in the "neighborhood," please stop by and have a look. I guarantee you will not be disappointed.

All of the sketches that I have just written about are available for purchase. Framed sketches are \$200.00 while unframed works are \$100.00. All proceeds will go to the Honorable Harry A. Cole Self-Help Center, so what we are presenting you with is the ultimate win-win. A classic piece of Baltimore legal history with the money going to a great cause.

WHY "THE GREAT GATSBY" & WHY THIS VERSION: First published in 1925, "The Great Gatsby" is considered a literary classic. In 1998, the "Modern Library" editorial Board voted it the 20th century's best American novel. Many of us have seen the DiCaprio version and undoubtedly quite a few have seen the Redford version, but if you are like me, you were probably unaware that there even was a version starring Alan Ladd. The cast includes screen legends such as MacDonald Carey; Ruth Hussey; Barry Sullivan; Shelly Winters; and Ed Begley.
